Whereas, there are no bicycle racks next to the Mathematics building or the Liberal Arts building.

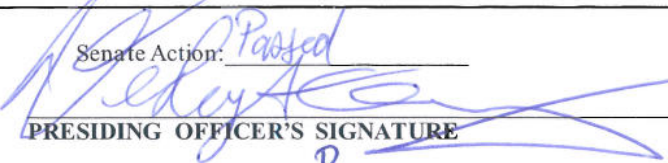

Whereas, currently the bicycles are being chained to the handrails and the courtyard gate.
