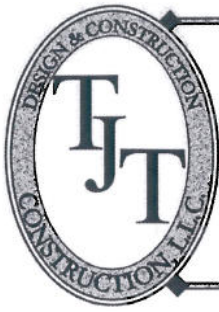

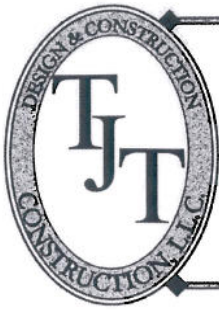

Re: Concrete Estimate – Performing Arts Center – 4'-0"x210'-0"

Dear Mr. Young,

Please let this letter serve as a written estimate of the costs associated with the following project scope of work that we discussed.

1. Sawcut and demo both sides of the street at the St. Anthony designated cross walk. Layout and form for two new handicap ramp accessible curb cuts.
2. Install reinforcing steel and dowel rods as necessary.
3. Supply and install two new ADA compliant dome mats at the curb cuts.
4. Supply, place and finish the new concrete to a broom finish.
5. Layout area to install a new sidewalk measuring 4'-0" wide by 210'-0" long starting from the new ADA compliant street curb cuts at St. Anthony Street approximately 68 linear feet, then turning approximately 45 degrees approximately 142 linear feet, then intersecting with the existing sidewalk at the building entrance. Attached is a sketch of the area.
6. Remove the tree roots that are in the direct path of the new sidewalk; approximately two to three roots.
7. Form for the new concrete. Supply and install 1x4 treated pine expansion joints approximately every 20'-0" on center.
8. Install a light guage, 10 gauge 6'x6" roll wire mesh.
9. Place and finish the new concrete to a broom finish.
10. Remove the forms, clean up the work area and haul away all of the trash created by this work.

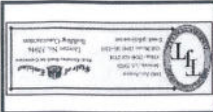
