FY 2022 - National Maritime Heritage Grant Program - Education Grants and Preservation Grants
Department of the Interior (Interior), National Park Service (NPS)

Notice seeking applications to fund education and preservation projects designed to preserve historic maritime resources and to increase public awareness and appreciation for the maritime heritage of the United States.

Applications for preservation grants are due September 9, 2022 and applications for education grants are due September 20, 2022. Approximately five Preservation awards ranging from \$50,000 to \$750,000 each, and approximately 15 Education awards ranging from \$25,000 to \$75,000 each are available.

BJA FY 22 Field Initiated: Encouraging Innovation
Department of Justice (Justice), Bureau of Justice Assistance (BJA)

Notice seeking applications to prevent and reduce crime and strengthen criminal justice system outcomes by collaborating with the field to identify, define, and respond to emerging or chronic crime problems and systemic issues. BJA is looking for proposed strategies to address these issues, including trying new approaches, addressing gaps in responses, building or translating research knowledge, or building capacity.

Applications are due July 6, 2022 for Grants.gov. Applications are due July 11, 2022 for JustGrants. Approximately \$8.43 million is available to fund nine awards.

FY22 Choice Neighborhoods Planning Grants

Department of Housing and Urban Development (HUD)

Notice seeking applications to support the development of comprehensive plans to revitalize severely distressed public housing and/or HUD-assisted housing and the surrounding neighborhood. Communities will develop a comprehensive neighborhood revitalization strategy, or Transformation Plan, to achieve the program's three core goals: Housing, People and Neighborhood. The Transformation Plan will become the guiding document to carryout subsequent implementation of the plan for the target housing units while directing the transformation of the surrounding neighborhood and positive outcomes for families.

Applications are due July 28, 2022. Approximately 20 Planning Grants of up to \$500,000 are available to support projects lasting up to two years. Eligibility is limited to public housing agencies, local governments, tribal entities, and non-profits but opportunities may exist for colleges and universities to collaborate.
