So I just wanted to update you on that, just give y'all like an insight on what's been going on behind the scenes with that. So that's great. My report is kind of short today. I also just wanted to remind y'all, Katie sent out a reminder this week, about the Faculty Senate Meeting. I still only have one senator reach out to me about going to that. Please- you know a lot of times you guys have things that are important to say I think that are important to say to the faculty or the people that run the University, which is ideally the faculty, because a lot of things they do directly affect us as students. So I think that some of us going to the Faculty Senate Meeting would make a difference or make a change or just show them that we do care about what's going on and what decisions they're making. To give y'all a little bit of insight what's going on behind the scenes: the Faculty Senate is considering or in the process- because they're just like us, they have a Senate, they have a President, they're considering removing all non-faculty members from the board, which would mean that there's nobody representing student body on the Faculty Senate Board. And I'm not saying- that's not a good thing. Our presence there shows them that we are here and if you have things to say, or we should be involved in some of the decisions. I do stand as a representative but just like our meetings when we have open forum, they have open forum as well. So any of us could go at any time. So that is something that's like in the process. It hasn't been 100% decided yet. I've honestly been fighting against that because I don't want us to not have any representation on that board, seeing as though we directly communicate, interact and work daily with the professors and things. So I wrote a statement for that. And there's another meeting next month. So I'm going to read the statement, well I wrote it last month and I was supposed to read it at this meeting, but it didn't happen so I'm going to be reading at the next one. So the next one that's in person, please don't forget to email me if you're interested in going I'd love to have more than just me and the execs or just me and one senator go. If anybody's available on that day just email me and I'll give you the details. And then the other thing is, I remember last week I told you guys I had the meeting was Diversity and Inclusion Board where I mentioned some things about the disability services with Amy King and she wanted to meet with me. So I had that meeting with her today. I'm not going to lie to y'all it didn't really go anywhere, but she said that she did want to come in person so that if you guys know anybody or have direct things you want to give her feedback on or say to her, y'all can relay that to her because I think it's better than just hearing it from me, just because I am the advocate for the student body. So hearing it from people who have experienced this- no one has told me anything directly. It's more of a word of mouth thing. So maybe it would be better for her to hear from multiple people or from the senate itself. So she's going to be coming to one of our senate meetings. I emailed Katie about that today. So she'll be setting that up. Not sure which meeting it's going to be but yes, so that's in the works. Right now. And there are two events that exact board is thinking about planning. So just keep your eyes and ears out for an email from us because we need volunteers. So we would love for y'all to help us with that. And then finally, Joy sent out an email to all of us recently about the recycling shindig and that's going to be on April 22. So I'm just make sure that you reach out to her. I don't know if she just sent it to us but if you're interested in participating in the tabling event for recycling or advocating for recycling, seeing as though we wrote the bill for the recycling and we pay for recycling on campus.
