This is a bill for the 2022-2023 University of Student Government Association Proposed Budget.

Whereas, the University of New Orleans Student Government Association Central Budget Committee, mandated by the SGA Constitution by means of the 1987 Student Referendum, is proposing the proposed budget of \$475,823.00.

Whereas, the UNO SGA Central Budget Committee convened on April 23rd and 25th, 2022, to form the 2022-2023 fiscal year SGA Budget.

Whereas, the UNO SGA Central Budget Committee has submitted a finalized budget for SGA Senate and Executive approval.

Whereas, the Administrative Budget will be allocated a total of \$137,360.00 from the SGA 2022-2023 proposed budget.

Whereas, the Budgeted Projects, to organizations, will be allocated a total of \$90,371.00 from the SGA 2022-2023 proposed budget.

Whereas, the Senate Operating Budget will be allocated a total of \$22,743.25 from the SGA 2022-2023 proposed budget.

Whereas, the Student Academic Travel Fund will be allocated a total of \$36,000.00 from the SGA 2022-2023 proposed budget.

Whereas, the Executive budget will be allocated a total of \$17,743.00 from the SGA 2022-2023 proposed budget.

Whereas, the Student Activities Council will be allocated 25% of SGA Funding, in accordance UNOSGA Constitution, which is numerated to a total of \$118,955.75 from the SGA 2022-2023 proposed budget.

Whereas, the Student Government Support Activities, defined as Leadership Cabinet, International Night, Recreation & Intramural Sports, and Scholarship Support will be allocated a total of \$52,650.00 from the SGA 2022-2023 proposed budget.
