When you look on our website, it tells you that we cannot accept screenshots. So what a lot of people have done on bills that have passed, they have attached their Amazon wishlist which makes it so much easier to order their items. So just when you are getting this legislation, I beg you, I implore you to just please make sure that the people who are asking for this money that they have submitted the necessary documentation in the right form. We do need like, if they're not ordering from Amazon, if they are not ordering from Office Depot, or like they're ordering from like a random vendor, which is fine. They have to submit actual quotes. If they're coming to you for our money, I'm not going to do the work for them. And you should not either. But the work that you should do is just to make sure that they have the supporting documentation submitted because what's happening is and what you guys are going to probably want it too, is that you're going to have a lot of people that these last couple of weeks submit bills; and it's unfair for us to have an organization that submit bills correctly

and risk the chance of not getting funded opposed to an organization that does not submit the bill correctly, and they take funding from organizations that submitted the bill correct. So as it's again, I asked you, once you're supporting these bills, please support them but just make sure that the documentation is correct. And if you need any questions, if you need any, if you're confused, there's a website or you can always come to my office, my door's always open ,or you can always send me an email, I'm so happy to help. The next thing, we have a middle school that is coming to visit that you see tomorrow, they're interested to see how Student Government Association works on a collegiate level. So we have grades fifth through eighth ,15 students who are a part of their student council. So we have a date planned for them. But I do need, I know it's last minute.
