Quorum was established for undergraduate and graduate voting.

Based on last week's meeting and the confusion regarding voting proxy being applied to the count for quorum, a new policy will be created for committee members.

A subcommittee meeting was held with input from Dr. Green, Prof. Hansen, Amanda Athey, Rajni Soharu, Sarah Berry, and Dr. Noyes. During the meeting, it was decided to deny the request to create FTA 5565 and FTA 5568 on the basis that a 6000 level course should not serve as a prerequisite for a 5000 level. Though done in the past, this is a bad practice which should be discontinued. It was recommend to the department that a 5000 level version of the needed 6000 level course should be submitted in its place.

Regarding the MFA in Creative Writing proposal, Rajni Soharu indicated that if the online program is the exact same version as the in-class program, then approval from SACS or the UL system is not needed. If there is a change to the curriculum, then approval would be needed and a new code would be assigned.

Dr. Green indicated that there are several items that will require further discussions, including but not limited to changing the UCCC meeting schedule, deadlines for new proposals, and form revisions. We discuss these during next week's meeting.

Sarah Berry informed the committee that she will contact the deans regarding new members for the new academic year. There are currently no term limits, so current members can remain if they and their respective dean so chooses.
