A Bill

This is a bill to accomplish the completion of the Student Lounge with four requests:

Whereas, the original bill requested \$56,506 from the UNOSGA, with the bill presenting some items as supported by the University. With the knowledge that the Student Lounge will be completely a UNOSGA project, we ask that additional funds of \$17,963 be added to the Student Lounge Project to complete the room.



Whereas, the UNOSGA would like to maintain the appearance, the functionality, and the modernity of the Student Lounge, the UNOSGA seeks to set up and maintain a maintenance fund by encumbering \$2,000 each fiscal year until the fund reaches \$10,000 maximum. These funds will be used to purchase new games, gaming systems, or furniture. Also, to maintain the cleanliness of floors and furniture, and the space in general. As the fund is used for these purposes, the fund will be replenished by \$2,000 each fiscal year until it reaches the maximum of \$10,000.

Whereas, the UNOSGA is funding the project of the Student Lounge in total, we ask the UNOSGA put forward a suitable name for University Room 110 for general use by the University.

Whereas, the UNOSGA is funding the Student Lounge, I request their opinion on the design of the wrap for interior and exterior windows. Choices: Updated UNO Privateer Logo wrap; Circles Wrap; Blend of both wraps.

 - II. To set up a Student Lounge Maintenance Fund by encumbering \$2,000 each year from remainder of SGA budget funds each fiscal year capped at \$10,000.


